Have you ever held office or served as BOD member in a corporation? No. However, I represented my government agency for several decades as the lead point of contact for myriad issues, including the establishment of the Director of National Intelligence, revamping the production of the Presidential Daily Briefing, technology integration lead for the implementation of mobile secure devices, and as executive lead for a number of community and agency projects. I was on the Chief Information Officer council that allocates information management budgets and prioritizes efforts. I also attended Saturday morning meetings with my boss (NGA Director Jim Clapper) with the leaders of all the intel agencies to work programmatics and strategy-somewhat of an informal intelligence community corporate board. I was also on the investment committee as an office chief running our In-Q-Tel projects, a quasi govt-commercial entity worked in collaboration with the Central Intelligence Agency, based out of Silicon Valley, Menlo Park, California, to invest in promising small businesses and entrepreneurs with leading edge ideas that are high risk and high payoff for the US government.

How would you describe your organizational skills & follow-through? I have strong organizational skills and follow-through with some 42 years of federal service as a government senior executive, military service (Army,) and five years as a government contractor. I led business units, managed large programs as the milestone decision authority, led technical developments and modernization upgrades for several decades. In the Army I served as a company commander on two separate occasions totaling 36 months, led eighteen tests to evaluate and make recommendations on the purchase of new equipment, served as a battalion level operations officer for a 2400-person unit, and later served as Executive Officer and briefly as Battalion Commander prior to my retirement, leading our response to the Northridge Earthquake of Jan 1994.
